#### SETTLEMENT AGREEMENT

The undersigned Agency and the undersigned Charging Party in settlement of the above matter, and subject to the approval of the Regional Director on behalf of the Federal Labor Relations Authority, HEREBY AGREE AS FOLLOWS:

POSTING OF NOTICE - The attached Notice to All Employees will be signed by Anne Mary Carter, Warden, FCI Morgantown. The Agency will post copies of the Notice in conspicuous places, including all bulletin boards and other places where notices to FCI Morgantown Food Services employees are customarily posted for a period of at least sixty (60) days from the date of posting. The Notice will also be sent electronically to all employees of the FCI Morgantown Food Services staff who are represented by AFGE, Local 2441, AFL-CIO. The email transmitting the Notice will contain the following language: We are distributing the attached Notice to Employees to you pursuant to a Settlement Agreement approved by the Washington Regional Director of the Federal Labor Relations Authority in Case No. WA-CA-14-0546

**COMPLIANCE WITH NOTICE** - The Agency will comply with all the terms and provisions of the Notice.

REFUSAL TO ISSUE COMPLAINT - In the event the Charging Party fails or refuses to become a party to this Agreement, and if the Regional Director concludes that it will effectuate the policies of Chapter 71 of Title 5 of the U.S.C., she shall decline to issue a Complaint herein and this Agreement shall be between the Agency and the undersigned Regional Director. A review of such action may be obtained pursuant to Section 2423.12(b)(2) of the Regulations of the Federal Labor Relations Authority if an appeal is filed within twenty-five (25) days thereof. This Agreement is contingent upon the General Counsel sustaining the Regional Director's action in the event of an appeal. Approval of this Agreement by the Regional Director shall constitute withdrawal of any Complaint(s) and Notice of Hearing heretofore issued in this case.

**PERFORMANCE** - Performance by the Agency of the terms and provisions of this Agreement shall commence immediately after the Agreement is approved by the Regional Director or, in the event the Charging Party does not enter into this Agreement, performance shall commence

immediately upon receipt by the Agency of advice that no appeal has been filed or that the General Counsel has sustained the Regional Director.

NOTIFICATION OF COMPLIANCE - The undersigned parties to this Agreement will notify the Regional Director in writing what steps the Agency has taken to comply herewith. Such notification shall be made within ten (10) days, and again after sixty (60) days, from the date of the approval of this Agreement, or, in the event the Charging Party does not enter into this Agreement, after the receipt of advice that no appeal has been filed or that the General Counsel has sustained the Regional Director.

**COMPLIANCE WITH SETTLEMENT AGREEMENT** - Contingent upon compliance with the terms and provisions hereof, no further action shall be taken in the above case.

# **NOTICE TO ALL EMPLOYEES**



## POSTED PURSUANT TO A SETTLEMENT AGREEMENT APPROVED BY A REGIONAL DIRECTOR OF THE FEDERAL LABOR RELATIONS AUTHORITY

In Case No. WA-CA-14-0546, the FLRA Washington Region found merit to AFGE Local 2441's charge that FCI Morgantown bypassed the Union when, after the Union had begun discussions with management about work schedules during Ramadan, management met with employees and solicited their views on that issue. Work schedules are a condition of employment of employees the Union represents.

To resolve this charge, FCI Morgantown has agreed as follows:

We will not bypass the Union by communicating directly with employees the Union represents about work schedules during Ramadan and other conditions of employment. We will deal directly with the Union as the employees' exclusive representative on such issues.

We will not in any like or related manner interfere with, restrain, or coerce employees in their exercise of rights assured by the Federal Service Labor-Management Relations Statute.
