## **ULP RESOLUTION**

In an effort to resolve ULP Charge Nos. AT-CA-14-0433, 0445, 0446 and 0448, on which the FLRA has issued a consolidated Complaint for hearing on April 7, 2015, the Department of Justice, Federal Bureau of Prisons, Butner Federal Correctional Complex (the Activity) and the American Federation of Government Employees, AFL-CIO, Local 408 (the Union) agree as follows:

- 1. The amicable settlement of disputes between Federal Agencies, Federal employees and Federal employee unions is encouraged and contributes to the public interest.
- By entering into this ULP Resolution, neither party is waiving any of their respective rights, nor is the Activity admitting any violation of the Federal Service Labor-Management Relations Statute (the Statute).
- Within 14 days of the date of the last signature on this ULP Resolution, the Warden of FCC Butner will issue a Memorandum of Assurance to the Union based on the attached template.
- 4. The parties shall complete a joint review of the post orders issued on or about April 8, 2014, by FMC Butner through Captain Wilson within 4 calendar months from the date of the last signature on this ULP Resolution. Within 14 days of the completion of the review, the Union may, in writing, request bargaining on any of the changes in working conditions made by the post orders that are within the scope of the duty to bargain under the Statute. The parties will thereafter bargain in good faith, and the results of such bargaining will be retroactive to the date a revised post order was adopted by the Activity.
- 5. The parties agree that the execution of this ULP Resolution by both parties is a request by the Union to withdraw ULP Charge Nos. AT-CA-14-0433, 0445, 0446, and 0448.
