OTHER ACTION TO BE TAKEN -

Respondent will provide the American Federation of Government Employees, Local 1637, AFL-CIO (Union), the information requested by the Union on January 27, 2012.

Respondent will post the required Notices on bulletin boards located in the staff lounge, the staff dining hall, the front lobby of the Federal Detention Center, and the front lobby of the Federal Correctional Institution.
