Crowder reported that District 14 is undertaking an effort to boost recruitment and has identified Local 2578 for this. among other locals. Coordinated events to meet this goal will be coming soon.

Crowder reported that the Local's Executive Board voted to reinstate the 100/100 recruitment bonus for new members and recruiters. For each enrollment, \$100 will be given to the member and the recruiter. AFGE national will reimburse the Local for a portion of this.

Representational Activity:

Crowder reported that there is no pending arbitration at this moment.

Crowder reported that AFGE and NARA are working on post-pandemic plans and the main topics of discussion are expansion of telework, maxiflex, and reasonable accommodations.

Crowder reported that the Hatch Act lawsuit was lost due to the decisions of a panel of conservative judges and currently the local and the legal team are considering next steps, if any.

Crowder reported that Amanda Weimer has joined as the new employee outreach coordinator.
