67.5 Hours of Donated Leave from her husband (02/20/07-03/02/07)

4.5 Hours of Advanced Sick Leave (Remaining hours on 03/02/07)

Pay Period #5 (03/04/07 - 03/17/07) 80 Hours of Administrative Leave

<u>Pay Period #6 (03/18/07 - 03/31/07)</u> 8 Hours of Administrative Leave (03/19/07)

4) Union Local 148 agrees that this settlement covers all issues outlined in the grievance dated April 27, 2007.

- 5) Union Local 148 agrees that they have the authority to sign this agreement on behalf of the employee named in Item 3 of this settlement agreement.
- 6) The Parties agree that this settlement agreement is being entered into due to the unique circumstances of the complaint and is not to be precedent for any other case.
- 7) All Parties agree that this settlement agreement does not constitute an admission of fault, guilt or wrongdoing by any party.
- 8) This agreement constitutes the entire agreement between the parties and there are no other terms, expressed or implied, except those written in this agreement.
- 9) The Parties declare that the terms of this agreement are fully understood and that they have voluntarily entered into and accepted this agreement.
