



Note: Due to NYS regulations and the value of benefits being offered through AFGE vs other sources, there is a slight delay in making AFLAC available to our members in NYS. It's in the works and will be available soon!

Life Insurance is now available to ALL AFGE members!

Transamerica Life Insurance is a NEW product that is:

- 1. Guaranteed issue: No medical questions other than "Do you smoke?"
- 2. An individual policy: you own it!
- 3. Portable: You take it with you if you change jobs, move etc.
- 4. Available with a death benefit of \$25,000 to \$150,000.
- 5. Guaranteed not to increase cost or decrease benefit to age 100.
- 6. Guaranteed to build cash value with interest rate of 4%.
- 7. Complete with long term care to match the death benefit value. You can use LTC at a rate of 4% a month for 25 months. If you need more you can then use Life Death benefit at 4% for another 25 months. If you use both up, Trans will issue a paid up \$25K life policy. Children can be added up to \$20,000 for \$2.30 a paycheck. At age 25 kids then choose a life policy for up to 5 times the value of their child policy with no medical questions. Spouses can also be covered.

Local Averts Agency Attempt to Contract Out

Local 2930 represents approximately 200 Wage Grade and GS employees at the US Army Corps of Engineers, Buffalo District, on the Canadian border of New York State. L2930 recently prevented the Agency from contracting out positions and influenced the decision to advertise for the vacant positions. Although the positions were outside the bargaining unit, Local 2930 and its members acted in the best interests of federal employees and the taxpayer in protecting our work.

In July 2017 the Local became aware of the Agency's intent to contract out services previously performed by a federal employee. The position had recently become vacant. The Agency chose not to advertise the vacancy, instead requesting higher headquarters approval and making other preparations for contracting out the work.

The Local researched information pertaining to the checklist and scope of work for the contract, position descriptions, staffing plans, and costs. This led to the determination that the Agency was using an outdated Army checklist, and the contractor would cost four times as much as a federal employee. Application of the proper checklist showed that the proposed contracting out was prohibited.

The Local informed the Agency of its findings and concerns, but the Agency argued that they had an exception to the prohibition. At this point the Local contacted the 2nd District and AFGE National staff for assistance. They advised that the Assistant Secretary of the Army (ASA) should be made aware of the situation, and that it would be best if he heard it from Army employees, so on August 9 the Local wrote to make him aware of the situation.

A response was received on August 10, an astonishing one-day turnaround. The ASA responded that DoD policy and statutory interpretation prohibits work designated for in-house government performance from being transferred to contractors. The ASA office requested contact information of the persons involved in the decision so they could discuss it with them. On August 30 the Local was asked to identify specifically (i.e., by job title, position description, TDA line, and UIC) which in-house positions would be adversely impacted by the proposed contract. About September 19th, the Agency notified the Local that the contracting out effort was dead and that a term vacancy was being advertised. Although a permanent position would have been preferable, a bargaining unit Employee was grateful for the opportunity to compete for the position. The ASA wrote that they are always happy to be of assistance. In my opinion this could not have happened without the full support of the employees, NVP Castellano and the AFGE staff.

Editor's Note: This success story also shows how, despite the current Administration's prohibition on labor-management forums, Agencies and the Union can work together to ensure better outcomes for both. In this case the Agency would have been in violation of its own policies and others and would have spent 4 times as much money, had the Union not shared its concerns for the good of all.

Arbitration Success

Local 2266 represents Border Patrol employees in the Swanton sector in northern VT and NY.

The Local recently won a second consecutive arbitration regarding safety equipment. The arbitrator ordered a return to status quo ante and that affected Employees be made whole. Award of attorney's fees is pending determination of the amount.

This case involved the Agency's failure to bargain over implementation of changes in cold weather uniform policy. As a result, agents were working in harsh conditions absent approved personal protective equipment.

Notably, in his decision the arbitrator referenced the



Local's previous win. He stated: "The ATV case parallels the current dispute. Both involve managerial decisions. Both involve an established practice. Both involve conditions of employment. Both now result in a finding of a violation of law and contract."

Kudos to the Local leadership including LP Sean Walsh and Treasurer Chris Porras (left) for relentlessly upholding contract and statute to ensure the safety of their bargaining unit members who perform critical national security missions.

2018 AFGE National Convention

13-17 August 2018, Las Vegas, NV

Locals should prepare now to participate! See the Events Calendar on afge.org for details, and watch for details on how to submit resolutions for consideration by the whole of AFGE.

Delegates at the 2015 Convention adopted the following definition of strong, effective Locals. Strong Effective Locals:

1) Have Leaders, including:

- Elected Officers as required by their Constitution and By-Laws, with a different person in each position;
- Union representatives and stewards, including Women's and Fair Practices Coordinators, YOUNG Coordinators and Local Political Coordinators;
- Activists and volunteers who are: Trained; Inclusive and representative of the bargaining unit in all its diversity, including different facilities, unit, job series, age, race, sex, etc.; and <content not displayed, please see afge.org afge.org/globalassets/documents/adopted-resolutions.pdf>.

2) Members:

- The Local has organizing and retention plans;
- A minimum of 50% of the bargaining unit employees are members;
- A significant number of members are active, including calling their member of Congress, volunteering for Local committees, recruiting new members, participating in Local meetings and activities; and
- <content not displayed, please see afge.org afge.org/ globalassets/documents/adopted-resolutions.pdf>.

3) Represent their members:

a. Through the Collective Bargaining Agreement (CBA), including: Timely bargaining; Training;
Enforcement; and Monitoring contracting out.
b. Through third parties, including: FLRA-PERB;
EEOC; EEOC; MSPB-OEA; OPM; OSC; DOL.

4) Meet their financial responsibilities:

- a. With an adequate dues structure providing funds to: Pay per capita; Participate in LAF; and Accomplish what is necessary to be a Strong Effective Local (1-6).
- b. With sound financial reporting and practices, including: Annual budgets approved by the members; The timely filing of DOL and IRS forms; Annual audits conducted; Monthly treasurer reports; and Properly bonded.

5) Participate:

- Through mobilization for: Legislative action, including lobbying; Political action; and workplace issues.
- In AFGE events, trainings, conventions, caucuses and meetings at the National, District, and, if applicable, Council levels;
- In state and local central labor councils; and
- In the community.
- 6) <u>Communicate and Educate</u>: To and from their members; To all bargaining unit employees; To allies; To the community; and with AFGE national, including through MYLocal and Personify.

FINANCIAL OFFICERS'



Sound financial management is imperative for all Locals so that legal obligations are met and members' money is properly used and accounted for.

For example, each Local must perform an annual audit and account to the IRS and DOL on its income and expenditures, by category. AFGE offers Financial Officers Training on a regular basis to assist Locals in meeting these and other obligations. Every Treasurer and Local President needs this class, and we advise that every member of the Executive Board take it as well to understand their fiduciary responsibilities.

The training is offered both by webinar or in a classroom setting. Currently webinars are scheduled for the following 2018 dates: Feb 20-22; April 24-26; Jun 19-21; Sep 11-13, and Oct 23-25. Classes will also be held at AFGE HQ in Washington D.C. as follows: Jan 22-25; Mar 19-22; May 21-24; and Jul 23-26.
