# Set forth a clear and concise statement of the facts constituting the alleged unfair labor practice, including date and location of the particular acts:

The National Park Service has knowingly permitted a member of its management team, Erin Lamm, to pursue a petition to decertify AFGE's National Park Service, Blue Ridge Parkway bargaining unit in case number AT-RP-22-0007 despite her status as a representative of agency management and the fact that she is not part of the bargaining unit at issue in that matter. Ms. Lamm accepted a position outside of the bargaining unit on or about July 1, 2022. She is now an HR Specialist with the Region. By allowing Ms. Lamm to seek to decertify AFGE's Blue Ridge Parkway bargaining unit following her change in position, the Agency violated its duty of neutrality in representation elections.
